### **Secretary of State for Competition, Deregulation and Consumer Affairs, Government of Argentina, 1999-2002.**

In charge of the institution building process of the Secretariat created in 1999. We developed an intense activity grounded on a technical approach, and we established the basis for state of the art regulatory policies and sectoral frameworks (telecom, postal services, etc) as well as anti-trust legislation and practice in a number of relevant markets (electricity, oil, postal services, media, medical services, etc). We proposed and achieved the reform of the Law of Competition (anti-trust). We also fostered consumer policies based on the economics of information and market transparency rather than discretionary distortive policies of previous decades.

### **Coordination for the Ministry of Economy of the Mercosur Macroeconomic Initiatives, 1999- March 2001.**
